

Obtaining a Qualified Persons License

Obtaining an Extinguishing Agent Handling Licence (EAHL) Qualified Persons (Entitlement 1-5)

Since late 2014, it has been mandatory for any person who handles ODS & SGG extinguishing agents to have gained the necessary qualifications to be able to obtain the appropriate EAHL - Qualified Persons.

To obtain a Qualified Persons licence you must demonstrate competence in the required units as listed in Table 322 of the Ozone Protection and Synthetic Greenhouse Gas Management Regulations 1995.

New applicants can apply for a Trainee EAHL (valid for a period of 12 months) to undertake the required training and assessment (Entitlement 1-5) enabling the person sufficient time to complete their training requirements. Once a trainee has completed the training and assessment modules successfully, they will be able to convert their trainee licence to a Qualified Persons EAHL.



Step One:

Contact a Registered Training Organisation (RTO) that offers the units of competency specified for the Qualified Persons license you require and talk to them about:

- Applying for a partial or full Recognition of Prior Learning; or
- Completing a program of 'gap' or whole of unit training; or
- A combination of both above

To find a registered Training Organisation that may be able to help:

Step Two:

Submit your application, together with certified copies of one or more Statements of Attainment listing all the units of competency required for the Qualified Persons License you need to:
