



### Fire Protection Industry (ODS & SGG) Board

# Do you have experience working as a sprinkler fitter and work on gaseous fire extinguishing systems containing a scheduled substance?

If you undertake installation and decommissioning work or testing and maintenance activities on gaseous fire extinguishing systems containing a scheduled substance you need to obtain an Extinguishing Agent Handling Licence (EAHL) - Qualified Persons (EAHL - Entitlement 2 or EAHL - Entitlement 3) as required by the Ozone Protection and Synthetic Greenhouse Gas Management Regulations 1995.

The information in this fact sheet may be of assistance in determining the easiest way for you to qualify for an EAHL - Qualified Persons. In some circumstances your existing qualifications may be sufficient to allow you to apply for an EAHL- Qualified Persons straight away without the need to undertake any further training or assessment.

#### What is the Sprinkler Fitting Mapping Guide?

The Sprinkler Fitting Mapping Guide offers credit transfer and recognition arrangements for several sprinkler fitting qualifications against the required units of competency from the CPP07 Property Services Training Package.

Competence must be demonstrated against these units, as required by the Regulations, before an individual can be issued with an EAHL - Qualified Persons.

- CPC32812, Certificate III in Fire Protection, delivery started 2013
- CPC32811, Certificate III in Fire Protection, delivery started 2012
- CPC32808, Certificate III in Fire Protection, delivery started 2010
- BCP30503, Certificate III in Fire Protection, delivered from 2005 to 2011
- 13190VIC, Certificate III in Sprinkler Fitting (Vic), delivered from 1999 to 2005
- 1200, Certificate III in Sprinkler Fitting (NSW), delivered from 1999 to 2005


